WITNESSETH:

WHEREAS, Authority owns and operates a sewer collection system in northern Palm Beach County; and

WHEREAS, Applicant is the fee simple owner of the property described on Exhibit "A" ("Property") attached hereto and made a part hereof; and

WHEREAS, Applicant desires to connect to the Authority's sewer collection system; and

WHEREAS, Authority has determined that all necessary recorded easements, or properly dedicated rights of way are in place for the low pressure sewer main extension; and

WHEREAS, in accordance with and subject to Authority and regulatory policies, procedures and requirements, Authority and Applicant wish to enter into this Agreement providing for sewer service to the property and extension of a low pressure sewer main to Applicant's furthest property line.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, the Authority and the Applicant do hereby agree as follows:

1. Existing Improvements

This Agreement authorizes sewer service only to the existing single-family home located on the Property. The parties agree that the addition of dwelling units or subdivision of the Property will require Authority approval and may result in additional fees and charges.

2. Private Grinder Pump System

Applicant agrees to install and maintain a private grinder pump system that will service the Property that meets Authority's specifications. Prior to initiation of sewer service, Applicant agrees to deliver an executed copy of Authority's standard Low Pressure Sewer System Maintenance Agreement confirming Applicant's maintenance responsibilities

3. Fees and Charges

To induce Authority to provide sewer service to the Property, Applicant hereby agrees to pay to Authority the following fees and charges listed on attached Exhibit "B".

- a. Connection Charges Payment for the allocable portion of sewer treatment plant and backbone collection system. Payment shall be due when the Applicant signs this Agreement.
- b. Administrative Fee Payment to defray the cost of plan review, inspection and engineering coordination. This fee shall be paid to the Authority at the time plans are submitted for review. No portion of this fee shall be refundable.
- c. Deposit This fee shall be paid upon submittal of the sewer service application form in accordance with Authority's Sewer Service Policy.

4. Engineering and Construction Costs

The Applicant shall, at its cost and expense and in accordance with all Authority and regulatory requirements, design, obtain permits for, construct, and certify the low pressure sewer main extension. Applicant shall submit a proposal from a civil engineer to design, permit and certify the sewer main extension and a proposal from an underground contractor to install and test the low pressure sewer main for review and approval by Authority; the sum of these two approved proposals will be the basis for calculating the contingent refund. These costs will be subject to reimbursement in accordance with Authority policy and limited as described on attached Exhibit "C".

5. Bill of Sale

Upon completion of construction of the low pressure sewer main extension and release for service by the Palm Beach County Health Department, applicant shall deliver a bill of sale prepared by the Authority for the new low pressure sewer main that will convey same to Authority for future ownership and maintenance.
