WATER MAIN EXTENSION AGREEMENT  
THIRD PARTY CONTINGENT REFUND**

This Agreement is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 202\_\_ between Seacoast Utility Authority, hereinafter referred to as "Authority", 4200 Hood Road, Palm Beach Gardens, Florida 33410, and \_\_\_\_\_ hereinafter referred to as "Applicant".

**WITNESSETH:**

WHEREAS, Authority owns and operates a water distribution system in northern Palm Beach County; and

WHEREAS, Applicant is the fee simple owner of the property described on Exhibit "A" ("Property") attached hereto and made a part hereof; and

WHEREAS, Applicant desires to connect to Authority's water distribution system; and

WHEREAS, Authority has determined that all necessary recorded easements, or properly dedicated rights of way are in place for the water main extension; and

WHEREAS, in accordance with and subject to Authority and regulatory policies, procedures and requirements, Authority and Applicant wish to enter into this Agreement providing for water service to the property and extension of a water main to Applicant's furthest property line.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, Authority and Applicant do hereby agree as follows:

1. Existing Improvements

This Agreement authorizes water service only to the existing single-family home located on the Property. The parties agree that the addition of dwelling units or subdivision of the Property will require Authority approval and may result in additional fees and charges.

2. Fees and Charges

To induce Authority to provide water service to the Property, Applicant hereby agrees to pay to Authority the following fees and charges listed on attached Exhibit "B".

- a. Connection Charges - Payment for the allocable portion of water treatment plant and water transmission system. Payment shall be due when the Applicant signs this Agreement.

b. Administrative Fee - Payment to defray the cost of document preparation, plan review, inspection and engineering coordination. This fee shall be paid to the Authority at the time plans are submitted for review. No portion of this fee shall be refundable.

c. Meter Fee – Cost to provide and install water meter, meter box and dual check valve. Payment shall be due upon submittal of the water service application.

d. Deposit - This fee shall be paid upon submittal of the water service application form in accordance with Authority’s Water Service Policy.

3. Engineering and Construction Costs

The Applicant shall, at its cost and expense and in accordance with all Authority and regulatory requirements, design, obtain permits for, construct, and certify the water main extension. Applicant shall submit a proposal from a civil engineer to design, permit and certify the water main extension and a proposal from an underground contractor to install, test and clear the water main for review and approval by Authority; the sum of these two approved proposals will be the basis for calculating the contingent refund. These costs will be subject to reimbursement in accordance with Authority policy and limited as described on attached Exhibit “C”.

4. Bill of Sale

Upon completion of construction of the water main extension and release for service by the Palm Beach County Health Department, applicant shall a deliver a bill of sale prepared by Authority for the new water main that will convey same to Authority for future ownership and maintenance.
