SEACOAST UTILITY AUTHORITY WATER MAIN EXTENSION AGREEMENT <u>WATER MAIN INFILL PLAN</u>

This Agreement is made and entered into this _____ day of ______, 202___ between Seacoast Utility Authority, hereinafter referred to as "Authority", 4200 Hood Road, Palm Beach Gardens, Florida 33410, and ______ hereinafter referred to as "Applicant".

WITNESSETH:

WHEREAS, Authority has established a Water Main Service Infill Plan (the "Plan"), which, as amended from time to time, is incorporated herein and made a part hereof and whose terms control in the event of conflict; and

WHEREAS, Applicant is the fee simple owner of the property described on Exhibit "A" ("Property") attached hereto and made a part hereof; and

WHEREAS, Applicant desires to connect to Authority's water distribution system; and

WHEREAS, Authority has determined that all necessary recorded easements, or properly dedicated rights of way are in place for the water main extension; and

WHEREAS, Authority has determined that sufficient funds are available for the water main extension as set forth in the Plan; and

WHEREAS, in accordance with and subject to the Plan and other Authority and regulatory policies, procedures and requirements, Authority and Applicant wish to enter into this Agreement providing for water service to the property and extension of a water main.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, Authority and Applicant do hereby agree as follows:

1. Existing Improvements

This Agreement authorizes water service only to the existing single-family home located on the Property. The parties agree that the addition of dwelling units or subdivision of the Property will require Authority approval and may result in additional fees and charges.

2. Fees and Charges

Fees - To induce Authority to provide water service to the Property, Applicant hereby agrees to pay to Authority the following fees and charges listed on attached Exhibit "B".

a. Pro rata share of Water Main Infill Plan – Payment for the allocable portion of the design and construction cost of the infill water distribution system evaluated in the Plan on a per parcel basis. Payment shall be due when applicant signs this agreement.

b. Connection Charges - Payment for the allocable portion of the water treatment plant and the water transmission system, based on equivalent residential connections. Payment shall be due upon submittal of the water meter application.

c. Meter Fee – Cost to provide and install water meter, meter box and dual check valve. Payment shall be due upon submittal of the water meter application.

d. Deposit - This fee shall be paid upon submittal of the water meter application form in accordance with Authority's Water Service Policy.

3. <u>Schedule</u>

Applicant acknowledges that Authority will be required to complete certain improvements to Authority's infrastructure which must be designed, permitted constructed and released for service prior to the availability of water service as authorized by this Agreement. Authority agrees to execute this work, but there shall be no liability whatsoever on Authority for failure to deliver service to Applicant according to the Owner's needs or schedules. This Agreement does not constitute a timetable for delivery of service, and no representation or warranty of such is expressed or implied. IN WITNESS WHEREOF, the Applicant has executed this Agreement as of the date first above written.
