**Footnotes:**

- 1 - Upon termination of services, customers may request a refund check for balances exceeding \$25.
- 2- Square Lake (Plat Book 23, Page 141, Official Records of Palm Beach County, Florida)
- 3- Work performed by Authority personnel on behalf of a Customer not otherwise covered in this service policy will be billed on an actual cost basis. This will include direct labor costs, overhead, actual materials cost, and a per-hour vehicle fee based upon the vehicle used and the most recent FEMA hourly rate.
- 4- Non-Residential Deposits are determined individually according to previous usage history and based upon the the average monthly billings available, times two (x2). New Non-Residential Deposits with no previous usage history will be charged based upon the amounts listed above.
- 5- If the meter is found to register above the accuracy limits prescribed, the fee will be refunded. If the meter is found to register within or below such accuracy limit, the fee will be retained. Upon written request of any Customer, and assuming the meter has not been tested within the last 12 month, without charge the Authority will make a field test of the meter's accuracy. Second requests within 12 months will incur a charge.
- 6- Sewer-only customers shall bear any additional costs associated with discontinuing and restoring service
- 7 - Per FL Statute 832.062, NSF Fee is 5% of the face amount of the returned payment or \$25, whichever is greater.
- 8- Land Development Fees shall be calculated as 4% of the full Connection Charges for units reserved under the corresponding developer agreement/ meter application. Land Development Fees, for buildings or which Connection Charges are being paid, shall be calculated as 2% of the full Connection for units reserved under the corresponding developer agreement/ meter application. If the calculated 4% or 2% fee is less than the minimum charge specified above, the minimum charge will apply. Building plan review is required for all structures meeting the following criteria:
  1. Water and Sewer facilities being constructed do not require Department of Environmental Protection or Florida Department of Environmental Protection permits and
  2. The facility to be served is other than single-family residential.Release of plans for submittal to permitting agencies or construction require all Land Development fees to be paid in full.
- 9 - Meter charges are payable at the time of the application. All Meters over 2" shall be installed by the Customer.
- 10 - Connection fees are based upon Palm Beach County rates and are subject to change. Fees increase with larger meters.
